Beneficiaries without health and long-term care insurance

In Germany, everyone must insure themselves against the risk of illness and care by law. As a rule, in the case of receipt of **citizen's allowance for employable beneficiaries**, **compulsory** insurance is included in the statutory

health insurance and social long-term care insurance.

In your claim for a claim, the requirements for compulsory insurance in the statutory health insurance scheme are and social long-term care insurance .

You must therefore take care of your insurance cover yourself immediately!

Please note: The Jobcenter does not cover any costs for people without health insurance coverage medical care. For the period without insurance cover, premiums/contributions may also be arrears and premium/late payment penalties .

You can obtain health insurance cover from an insurance company of the private health insurance company.

Please first contact a statutory health insurance company of your choice. The latter will check their assignment. Meet the insurance requirements for voluntary membership in the statutory health insurance scheme

You can freely choose a statutory health insurance provider within the framework of the general right to choose your health insurance provider . These

may not refuse membership. Meet the requirements for assignment to the private system

health insurers, the private health insurance companies are obliged to provide you with a health and care

insurance in the so-called basic rate. In some cases, your job center can provide a subsidy to the contributions under legally determined conditions

pay. Such a subsidy can also be paid if you are not entitled to benefits for the security of the

subsistence under the Second Book of the Code of Social Law, but would be in need of assistance as a result of the payment of the contributions. Next
